*Welcome to Giftet.*

### Scope of Giftet Privacy Details Statement

This statement applies to Giftet Web Sites on the World Wide Web.

### Important Statement about Your Personal Information

In general, you can visit Giftet website on the internet without telling Giftet who you are or giving Giftet your personal information. There are times when Giftet may need information from you, for instance: to process an order, to correspond, to provide a subscription or in connection with a job application. Giftet may supplement this information to complete a transaction or to provide a better service.

You may choose to give us personal information in a variety of situations. For example, you may want to give us information, such as your name and address or e-mail id, to correspond with you, to process an order, or to provide you with a subscription. You may give us your credit card details to buy something from us or a description of your education and work experience in connection with a job opening at Giftet that you wish to be considered for. Giftet intend to let you know how Giftet will use such information before Giftet collect it from you; if you tell us that you do not want us to use this information to make further contact with you beyond fulfilling your requests, Giftet will respect your wishes. If you give us personal information about somebody else, such as a spouse or work colleague, Giftet will assume that you have their permission to do so.

### Using and Sharing your Personal Information by Giftet

The following paragraphs describe in more detail how Giftet may use your personal information and with whom Giftet may share it. Depending on the type of Giftet Web site you are visiting, one or more of the paragraphs may apply. For example, if you order a product from a Giftet Web site, your information will be handled as described in such paragraphs as Fulfilling Your Transaction Request and Marketing Use.

### Fulfilling your Transaction Request

If you request something from a Giftet Web site, for example, a product or service, a callback, or specific marketing materials, Giftet will use the information you provide to fulfill your request. To help us do this, Giftet may share information, with others, for instance, other parts of Giftet, Giftet's Business Partners, financial institutions, shipping companies, postal or government authorities (for example, Customs authorities) involved in fulfillment. In connection with a transaction Giftet may also contact you as part of our customer satisfaction surveys or for market research purposes.

### Marketing Use

The information you provide to Giftet on certain Giftet Web sites may also be used by Giftet and selected third parties for marketing purposes. Before Giftet use it, however, Giftet will offer you the opportunity to choose whether or not to have your information used in this way.

### Giftet Human Resources Web Sites (including Recruitment)

In connection with a job application or inquiry, whether advertised on a Giftet Web site or otherwise, you may provide us with information about yourself, such as a resume or curriculum vitae. Giftet may use this information

throughout Giftet and its related entities for the purpose of employment consideration or your inquiry. Except where you tell us not to, Giftet will keep the information for future consideration.

### **Information for Business Partners**

If you represent a Giftet Business Partner, you may visit a Giftet Web site intended specifically for Giftet Business Partners. Giftet may use information provided on that site to administer and develop our business relationship with you, the Business Partner you represent, and Giftet Business Partners generally. For instance, this may involve using your information to send you details of Giftet Business Partner programs. It may also include sharing certain information with other Business Partners (subject to any confidentiality obligations that may exist), or Giftet customers or prospects. In connection with a particular transaction or program, Giftet may also contact you as part of customer satisfaction surveys or for market research purposes.

### **Giftet Supplier Administration**

If you represent a Giftet supplier, you may visit a Giftet Web site intended specifically for use by Giftet suppliers. Giftet may use the information provided on that site in connection with entering into or performing a transaction with you. For example, this may include sharing information with other parts of Giftet, Giftet's Business Partners, customers, shipping companies, financial institutions, postal or government authorities involved in fulfillment. It may also be used to administer and develop our relationship with you, the supplier you represent and/or other Giftet suppliers generally.

### **Giftet Discussion Forums and Chat Rooms**

If you participate in a Giftet discussion forum or chat room, you should be aware that the information you provide there will be made broadly available to others, potentially inside or outside Giftet, who have access to that discussion forum or chat room. Also, please recognize that individual forums and chat rooms may have additional rules and conditions. Each participant's opinion on a forum or chat room is his or her own and should not be considered as reflecting the opinion of Giftet.

### **Other Giftet Web Site Notices**

In some cases, specific Giftet Web sites may contain other notices about their use and the information practices applicable to those sites.

### **Giftet Worldwide Practices**

Giftet is a global organization, with legal entities, business processes, management structures, and technical systems that cross borders.

Giftet privacy practices are designed to provide protection for your personal information, all over the world.

Giftet may share your personal information within Giftet and transfer it to countries in the world where Giftet does business.

Some countries may provide less legal protection for your information. In such countries Giftet will still handle information in the manner Giftet describe here.

### **Information Security and Quality**

Giftet intends to protect your personal information and to maintain its quality. Giftet intends to implement appropriate measures and processes, such as using encryption when transmitting certain sensitive information, to help Giftet keep your information secure and to maintain its quality.

### Supplementing Information

From time to time Giftet may supplement information you give us via Giftet Web site with information from other sources, such as information validating your address or other available information about businesses. This is to help us maintain the accuracy of the information Giftet collect and to help us provide a better service.

### Use of Suppliers

In some cases Giftet uses suppliers to collect, use, analyze and otherwise process information on its behalf. It is Giftet's practice to require such suppliers to handle information in a manner consistent with Giftet's policies.

### Mergers and Acquisitions

Circumstances may arise where, whether for strategic or other business reasons, Giftet decides to sell, buy, merge or otherwise reorganize businesses in some countries. Such a transaction may involve the disclosure of personal information to prospective or actual purchasers, or receiving it from sellers. It is Giftet's practice to seek appropriate protection for information in these types of transactions.
